# If you are:

- 3. You were instructed to fill out the sign-up sheet outside the stage OR
- 4. Your ID was taken by the Proctor's Office for further investigation, and you have met with a Proctor on Sunday, Sept 4 or later AND the Proctors have cleared you for advising.

#### YOU MUST COMPLY WITH THE FOLLOWING INSTRUCTIONS:

- Your name and ID number must appear on the Final Opportunity List (available from <a href="http://www.sbeadvising.com/announcements.html">http://www.sbeadvising.com/announcements.html</a>). If your name is not on this list, you will not be allowed inside the auditorium.
- 2. You must be present in the NSU Auditorium (adjacent to Gate no 8) at **10 AM on 8**<sup>th</sup> **September**.
- 3. Your parent or legal guardian must accompany you.
- 4. You must bring your student ID, your national identification card (NID) or your passport.
- 5. Definition of parent: Father or Mother. Your father or mother must also bring their NID or passport. Copies are not acceptable.
- 6. Definition of Legal Guardian:
  - a. Someone who pays for your tuition and fees, AND
  - b. You live with this individual
  - c. You can prove your relationship with your Legal Guardian through identification documents
  - d. Your legal guardian must also bring his or her NID or passport verifying relationship with you. Copies are not acceptable.

- e. If your husband is your legal guardian, you must bring your original marriage certificate (Nikah-Nama), and your husband's NID or passport. Copies are not acceptable.
