South Asian Institute of Policy and Governance (SIPG) was formally inaugurated in 2008 as a tailormade education and research program under the then Department of General and Continuing Education. The International Master degree program in Public Policy and Governance had been a landmark in the history of North South University in Bangladesh. The program has been able to attract a formal recognition as an attractive centre of higher learning of the incumbent young civil servants of the Government of Bangladesh and other South Asian Countries (Sri Lanka, Bhutan and Nepal). Till 2022, the MPPG program has produced more than 170 graduates from Bangladesh, Bhutan, Nepal, Sri Lanka and Malaysia.

To become a leading academic institution and think tank on policy and governance

SIPG runs Master in Public Policy and Governance (MPPG) Program which educates young professionals in public policy and governance and follow interdisciplinary approaches covering policy, development economics, political science and comparative governance including gender, culture, and society. It prepares the students to undertake applied analysis by developing institutional designs which can transform public administration system and overall quality of public services in the region.

The institute strives to undertake an inventory of the key thematic challenges related to public policy and attempts to develop a collective and synchronized strategy to address such challenges through research and education.



Master in Public Policy and Governance (MPPG) is an international master degree program started in 2008 in collaboration with University of Bergen (UiB), Norway; Tribhuvan University (TU), Nepal; and University of Peradeniya (UoP), Sri Lanka. The MPPG program is designed for the Civil servants from Bangladesh, Nepal, Bhutan, Sri Lanka and other South and East Asian Countries. MPPG students complete one semester in a reputed university from Europe or South East Asia. Till 2022, 10 batches of MPPG students have already been graduated from North South University.

It aims to strengthen academic competence and professional skills among professionals from public bureaucracy, development executives, embassy officials, managers of NGO, private sector officials in Bangladesh.



Publications


