The Department of Law of North South University invites the submission of brief papers for the upcoming online event of **Undergraduate Law Symposium Fall 2021** on manuscripts on any aspect of Bangladeshi legal system, comparative law, international legal matters, and interdisciplinary study of law. However, a topic exclusively dealing with national jurisdiction, other than Bangladesh would not qualify. The selected papers will be called for presentation online/ on campus. Any student enrolled in an LL.B. (Honours) programme in a Bangladeshi institution would be eligible to submit a paper.

The word limit for the paper is not more than 3,000 words (excluding footnotes and abstract), with the abstract not being more than 150 words. The page format should be A4 size with 1.5-line spacing and 12 point Times New Roman font. The font for footnotes should be 10 point Times New Roman. The citation style should be Bangladesh Style of Citation of Legal Authorities (BSCLA) or Oxford Standard for Citation of Legal Authorities (OSCOLA). The paper should have a title. Participants are required to submit their paper in MS Word format. Any personal identification information of the author such as their name, the name of their university, etc. should not be present in the paper submitted. Any such paper will not be accepted.

The deadline for submission of papers is **11:59 PM, 9 December 2021**. Only some papers will be selected for presentation. The selected authors will be notified by **19 December 2021** for presentation on **23 December 2021**.

The winner and runner-up to be chosen by a panel of experts will receive prize money of BDT 7,000 and BDT 5,000 respectively along with crests and certificates. All participants will receive an electronic certificate of participation. Subject to any linguistic or stylistic changes as deemed appropriate by the Department of Law, North South University, the best paper/papers may be uploaded to the North South University Department of Law's website for further dissemination.
